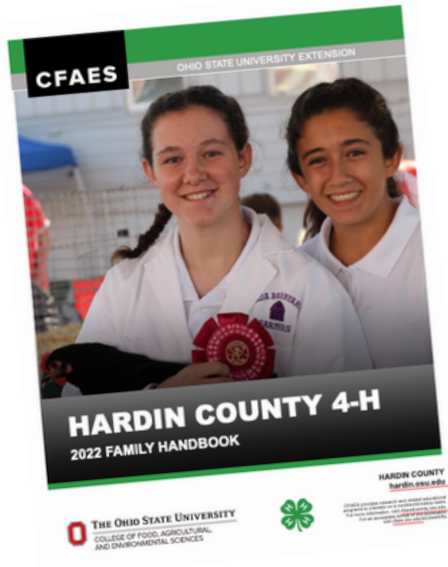

QUALITY ASSURANCE

All members enrolled in a market livestock or lactating dairy project must complete Quality Assurance Training to participate in the Hardin County Fair or Ohio State Fair.

There is on **LAST CHANCE** to complete Quality Assurance.

Members who do not complete QA will NOT be able to show/sell at the Hardin County Fair.



Did you know?

Quality Assurance is required by law.

Youth must complete 45 days prior to the start of the fair, as per Ohio Revised Code.
